International Golf Federation DAM Terms of Use

International Golf Federation ("**IGF**") owns and operates a photo, audio and video archive site located at https://dam.igfdigital.com/ (the "**Site**"). BY ACCESSING OR USING THE SITE, YOU AGREE TO BE BOUND BY THESE TERMS OF USE. IF YOU DO NOT AGREE TO THESE TERMS OF USE, YOU MAY NOT ACCESS THE SITE.

- 1. **Acceptance of Terms of Use**. Each time you access the Site, you agree to be bound by these Terms of Use, as the same may be amended by IGF from time to time, with or without notice to you.
- 2. **Permitted Uses**. IGF grants you a revocable, limited, non-transferrable, non-sublicensable right to access the Site to review and/or use content, images, footage and/or videos (the "Content") for the limited purpose agreed to by IGF and you pursuant to a separate agreement at the time you confirm a Content order (the "Permitted Use"). If IGF determines that your use of the Site violates these Terms of Use and/or the Permitted Use at any time, IGF may immediately suspend and/or terminate your Credentials with or without notice to you.
- 3. **Account Access**. In order to access the Site, you will need an IGF-issued username and password. The unique username and password (the "Credentials") issued to you or your organization (each, an "Authorized User") by IGF will provide you (or your organization, as applicable) access to the Site for purposes of the Permitted Uses outlined above. As an Authorized User, you agree to the following terms:
 - 1. you will use accurate, complete and true information to register for a username and password with IGF and you agree that such registration will be subject to IGF's <u>privacy policy</u>;
 - 2. you will not share or disclose your username and/or password with any other entity;
 - 3. you will be solely responsible for maintaining the security and confidentiality of the username and password provided to you by IGF;
 - 4. you will immediately notify IGF in the event you become aware of or suspect unauthorized use or any other breach of security relating to your username and password.
- 4. **Monitoring**. IGF may monitor the use by any Authorized User of the Site. During monitoring, any information relating to your use of the Site may be copied, examined, recorded and/or used by IGF in order to enforce these Terms of Use and in accordance with IGF's privacy policy.
- 5. **Ownership**. You acknowledge and agree that IGF and/or its licensors, as applicable, exclusively owns all and any Content that may be accessed and/or used through the Site. You do not and will not have or acquire all or any interest, title and/or rights in or to the Content by virtue of this agreement and/or your access to and/or use of the Content. Any use of the Content by you shall be subject to a separate agreement between IGF and you.
- 6. Clearances. Unless otherwise provided in writing, IGF does not provide any third-party releases with respect to the Content and grants no rights and makes no warranties with regard to the use of names, people, trademarks, trade dress, registered, unregistered or copyrighted designs or works of art or architecture depicted in the Content. You shall be solely responsible for determining whether a clearance or release is required in connection with any proposed use of the Content.
- 7. Limitation of Liability. IN NO EVENT WILL IGF BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, PUNITIVE, OR SPECIAL DAMAGES (INCLUDING WITHOUT LIMITATION DAMAGES RELATING TO LOST PROFITS, LOST DATA OR LOSS OF GOODWILL) REGARDLESS OF WHETHER THE ALLEGED LIABILITY IS BASED ON CONTRACT, TORT, NEGLIGENCE, STRICT LIABILITY, OR ANY OTHER LEGAL OR EQUITABLE THEORY, AND EVEN IF IGF HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. WITHOUT LIMITING THE FOREGOING, YOU AGREE THAT (A) IN NO EVENT WILL IGF BE LIABLE FOR ANY LOSS OR DAMAGE ARISING OUT OF YOUR FAILURE TO COMPLY WITH SECTION 3 ABOVE, AND (B) IGF'S AGGREGATE LIABILITY TO YOU IN CONNECTION WITH

- YOUR USE OF THE SITE AND/OR THESE TERMS OF USE SHALL NOT EXCEED ONE HUNDRED UNITED STATES DOLLARS (USD\$100).
- 8. **Indemnification**. You agree to defend, indemnify, reimburse and hold harmless IGF and its affiliates, and their respective agents, directors, employees and officers from and against any and all actions, claims, damages, demands, judgments, liabilities, losses, proceedings, suits and/or costs and expenses (including without limitation reasonable attorneys' fees and court costs) arising out of or related to (a) your use of the Site, (b) your use or misuse of any Content, (c) any breach of these Terms of Use, and (d) any misrepresentation by you in connection with your application for Credentials.
- 9. **Reservation of Rights**. IGF reserves the right to modify and/or update the Site and/or any software utilized in or by the Site, at any time and with or without notice.
- 10. **Termination**. IGF may, in its sole discretion, suspend and/or terminate your Credentials without prior notice for any or no reason, including but not limited to (a) permitting another person or entity to access or use the Site through such Authorized User's Credentials, (b) any unauthorized access or use of the Site, (c) any violation of these Terms of Use, and/or (d) tampering with or altering any software and/or Content contained in or accessed through the Site. IGF also reserves the right to suspend and/or terminate your Credentials for non-use in the event your Credentials have not been used to access the Site during any one hundred eighty (180) day period. You may terminate your account at any time for any or no reason. Termination, suspension, or cancellation of these Terms of Use or your access rights to use the Site shall not affect any right or relief to which IGF may be entitled, at law or in equity. Upon such termination, suspension, or cancellation, all rights granted to you will automatically terminate, and you shall promptly delete the Content from your computers and other electronic storage systems.
- 11. **Miscellaneous**. These Terms of Use and the relationship between you and IGF shall be governed by the laws of Switzerland without regard to conflicts of law provisions. Any action or proceeding arising from these Terms of Use and/or your use of the Site shall be brought exclusively in Lausanne, in the Canton of Vaud, Switzerland, and you irrevocably consent to the personal jurisdiction of such courts. No failure or delay by IGF in exercising any right, power or privilege under these Terms of Use will operate as a waiver thereof without such waiver being in writing signed by IGF. The invalidity or unenforceability of any provision of these Terms of Use will not affect the validity or enforceability of any other provision, all of which will remain in full force and effect. These Terms of Use represent the entire understanding of the parties regarding its subject matter, and supersede all prior and contemporaneous agreements and understandings between the parties regarding its subject matter.
